### **FOR IMMEDIATE RELEASE:**

The International Health Regulations were created by the World Health Organization (WHO) to facilitate information sharing and international health measures through advisory procedures in an increasingly connected world. WHO is in the final stages of implementing more than 300 amendments to the existing International Health Regulations (IHR) at the upcoming World Health Assembly meeting in Geneva (May 21-30, 2023) fundamentally altering WHO from an advisory body to one whose legally binding dictatorial powers will control virtually every aspect of national and personal life around the globe. Under these amendments, all authority for these decisions will be vested in a single person, WHO's Director General, giving him/her absolute, unchallengeable power to eliminate national and personal sovereignty. Those powers extend to travel and freedom of movement, health, manufacturing and other economic activity, forced medical treatments, digital IDs/health certificates and more. The revised IHRs do not require national ratification!

If approved by a simple majority of the 194 member nations of the WHO, all member nations will be bound by the powers granted to the WHO Director General under the amendments unless a member nation exercises its right of rejection within the allotted time allowed.

Citizens around the world are demanding that their countries leave the WHO and its parent organization, the UN, and oppose the amendments during the upcoming World Health Assembly

These amendments have been submitted and negotiated in secret meetings absent any meaningful public input since "Relevant Stakeholders" do not include any member of the public.

These proposed changes<sup>2</sup> contain alarming alterations to the existing IHR. For example, a proposed change in Article 3 eliminates the existing language “with full respect for the dignity, human rights and fundamental freedoms of persons.”<sup>3</sup> Article 3 articulates the guiding principles and limitations of the IHR, so the omission of these terms is absolutely egregious. The amendments repeatedly eliminate critical language, such as “non-binding”, transforming IHR *guidance* into *forced compliance* by all member states.

WHO’s corrupt and dangerous reality bears little resemblance to the benevolent image broadcast to the public. The current Director General, Tedros Adhanom Ghebreyesus, to whom the proposed amendments transfer virtually unilateral power, has a disturbing background prior to his tenure at the WHO<sup>4</sup> which includes the genocide of more than one million Ethiopians.

WHO’s funding structure makes it clear that the organization is fundamentally compromised<sup>5, 6, 7, 8, 9, 10</sup>, serving the special interests of its institutional and commercial funders.

Importantly, the WHO has publicized its plan to “introduce 500 new vaccines<sup>2</sup>” by the year 2030. Given the language in the IHR amendments, member states would be *compelled* to implement vaccine mandates in their respective countries, or face penalties for their non-compliance. These WHO directives would supersede any existing laws protecting the rights of citizens in member nations. In order to prevent the end of national and personal sovereignty, these amendments must be rejected by popular demand. Your active participation in bringing this information to public awareness is essential.
